To deliver the Maths Circles intervention on behalf of Axiom Maths, The Tutor Trust will need to collect data on those students nominated to receive tuition, in addition to some data from specific school/college staff and parents. This privacy notice gives you information on how we collect and process the data before, during and after the programme is delivered. Axiom Maths will use some of the data collected by The Tutor Trust for their own reporting and impact evaluation – further information about their use of personal data is available [here](#).

We have appointed a data protection officer (DPO) who is responsible for monitoring and providing guidance with our data protection obligations. If you have any questions about this privacy notice, please contact the DPO/us using the contact information in section 11 of this privacy notice.

What will this intervention involve?

We deliver tuition to Maths Circles on behalf of Axiom Maths. Maths Circles are small groups of pupils meeting weekly to work through a structured curriculum of challenging problems, beyond what they would ordinarily be exposed to in the National Curriculum.

Tuition runs for 30 weeks each academic year and is fully funded by Axiom Maths. Pupils join the project in Year 7 and continue through until Year 11.

Lawful basis of processing information

We only collect and use personal information when the law allows us to. Most commonly, we use it where:

- The data subject (you) has given consent to the processing activity taking place.
- If the processing is necessary for the performance of a contract.
- If the processing is necessary for compliance with a legal obligation to which the controller is subject.
- If the processing is necessary for the purpose of the legitimate interest pursued by us. For this intervention our legitimate interest is to facilitate the successful running of the programme.

For the processing of special category data, we will process it under one of the below conditions:

- Explicit consent
- Employment, social security and social protection (if authorised by law)

- Reasons of substantial public interest. This can be for equality of opportunity or treatment, support for individuals with a particular disability or medical condition, insurance or statutory and government purposes.

Why do we process this personal data?

We ask for data about the learners who will receive tuition in order to deliver the tuition programme effectively, and to monitor the impact of tuition.

Who will the data be shared with?

To facilitate this programme, the above-mentioned data will be shared between The Tutor Trust and your school/college. The Tutor Trust will transfer no personal data outside of the EEA for the delivery of this intervention.

Student data will be shared with Axiom Maths. All data will be shared securely, via an online portal (the Axiom Hub), in line with data protection policies and

procedures. Axiom Maths will use the data for various purposes, as listed in their Privacy Notice [here](#).

For existing students on the programme (those who joined prior to the 2024/25 academic year), we require explicit parental consent for their continued participation, and for their data to be uploaded to the Axiom Hub. Please follow the opt-in process as outlined in the parental letter you will have received.

Axiom Maths transfers personal data to countries outside of the EEA, but only where appropriate safeguards are in place (such as the International Data Transfer Agreement or the International Data Transfer Addendum) or an adequacy decision is in place, in line with data protection legislation. How long will the data be held?

We pride ourselves on ensuring that the personal data is only retained for the period that we need it for, or in accordance with laws, regulations and professional obligations that we are subject to. All personal information collected has a defined retention period, which is in-line with our retention policy. In this case, data will be retained for 1 academic year post the student's last interaction with the Axiom Maths programme. Please see the "additional information" section of this policy to contact us for further information.

Security of data

We take the responsibility for protecting your privacy very seriously and we will ensure the personal data provided is secured in accordance with our obligations under the Data Protection laws. We have in place technical and organisational measures to ensure personal information is secured and to prevent data from being accessed in an unauthorised way, altered or disclosed. We have in place a robust access control policy which limits access to the data to those employees who only have a business need to know.

We have policies and procedures to handle any potential data security breaches and data subjects, third parties and any applicable regulators will be notified where we are legally required to do so.

Failure to provide requested information

Where we need to collect personal data in order to process your instructions or deliver the tuition we have agreed with you and you fail to provide that data when requested, we may not be able to carry out tuition or evaluate the impact. In this case, we may have to cancel our engagement, but we will notify you if this is the case at the time.

Your rights

In this Section, we have summarised the rights that you have under General Data Protection Regulation. Some of the rights are complex, and not all the details have been included in our summaries. Accordingly, you should read the relevant laws and guidance from the regulatory authorities for a full explanation of these rights.

Your principal rights under General Data Protection Regulation are:

The right to object

You can exercise this right if

- Processing relies on legitimate interest
- Processing is for scientific or historical research
- Processing includes automated decision making and profiling
- Processing is for direct marketing purposes

The right of access

- You or any third party acting on your behalf with your authority may request a copy of the personal data we hold about you without charge.
- We will ask to verify your identity or request evidence from the third party that they are acting on your behalf before releasing any personal data we hold about you.

The right to be informed

- We are required, to provide clear and transparent information to you about how we process your personal data. This privacy notice addresses this right.

The right of rectification

- If you believe the personal data we hold about you is incorrect or incomplete you have the right to correct this and you may exercise this right along with the right to restrict processing until these corrections are made.

The right to erasure

- If there is no legal basis or legitimate reason for processing your personal data, you may request that we erase it.

The right to restrict processing

- You may ask us to restrict the processing of your personal data. This means we will still hold it but not process it. This is a conditional right which may only be exercised when:
 - Processing is unlawful
 - We no longer need the personal data, but it is required for a legal process
 - You have exercised your right to object to processing and require processing to be halted while a decision on the request to object is made.
 - If you are exercising your right to rectification

The right to data portability

- You can request that your personal data is transferred to another controller or processor in a machine-readable format if:
 - Processing is based on consent
 - Processing is by automated means (i.e. not paper based)
 - Processing is necessary for the fulfilment of a contractual obligation

You also have the right to withdraw your consent where, consent has been provided. If you wish to withdraw your consent, please email the below email address. Please note this does not affect the lawfulness of any data processing prior to the withdrawal.
